RE: Per- and Polyfluoroalkyl substances (PFAS) in Drytac Digital Print Media- North America

PFAS are fluorinated substances used to make fluoropolymer coatings that resist heat, oil, grease, and water. It contains any compound with at least one fully fluorinated methyl or methylene carbon atom (without any H/Cl/Br/I atom attached to it), i.e., with a few noted exceptions, any chemical with at least a perfluorinated methyl group ($-CF_3$) or a perfluorinated methylene group ($-CF_2-$) is a PFAS. These substances are identified to persist in the environment and are known as “forever chemicals”.

All raw materials used in the manufacture of the items listed below do not contain intentionally added PFAS above 0.1%, and PFAS are neither added nor used in the manufacturing process.
